This document waives important legal rights. Read it carefully before signing. I AGREE in consideration for my participation in this Competition, GO February Schooling Show, to the following:

I **AGREE that** I choose to participate voluntarily in the competition with my horse, as a rider, handler, owner, agent, coach, trainer or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. ("Harm")

I **AGREE** to release the Oklahoma City State Fair Grounds and the GO Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the Oklahoma City State Fair Grounds or the GO Competition.

I **AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Oklahoma City State Fair Grounds or the GO Competition.

I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) the Oklahoma City State Fair Grounds and the GO Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse to the competition. If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and **AGREE** to all the above provisions and **AGREE** to assume all of the obligations of this Release on the child's behalf. I **AGREE** that the "Oklahoma City State Fair Grounds and the GO Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations. I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I **AGREE** that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Oklahoma City State Fair Grounds and GO Competition.
